Be sure you write "BID ENCLOSED" on the sealed envelope. Bids will be accepted until November 1st 2019 (RLFPOA members must be in good standing)

New dumpster contract to empty 5 dumpsters twice a week seems to have really helped with overflow this summer. The change to twice a week has actually saved us money too! Still seeing illegal dumping. If caught, violation of \$100 will be given. Be sure to smile to the camera!

Reminder boat dock is for loading and unloading for boats. No tying boat to dock, fishing or diving off dock. New sign as a reminder has been placed on the beach.

Water diverters have been placed at the beach parking lot and have really done the job of stopping the erosion and wash-away of beach stairs and walkway. This was a temporary fix to address the issue and test if it would work. Something more permanent will be built in the future.

As was voted on by RLFPOA at the spring members meeting, water, showers and septic will be closed November 1st to May 1st.

Enclosed in this newsletter to members that were not at the fall members meeting is a summary of covenants, bylaws and rules of RLF. There are multiple subdivisions within the forest. It is the member's responsibility to identify the restrictions based on subdivision and lot location.

Please let us know if you have a new mailing address. We need to keep you informed and make sure you get assessments mailed to correct address. On that note....there are still unpaid assessments. Unpaid assessments will prevent you from using facilities within the forest. Beach, bathrooms, dump, pavilion, sanitation, docking, etc. are kept and maintained by paid assessments.

FYI- Member Dave Chandler wanted to let members know about Oak Wilt. This is a disease that can be spread by cutting or trimming Red Oak trees April 1st through July 31st.
